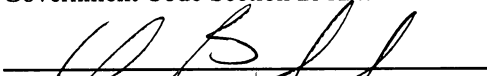

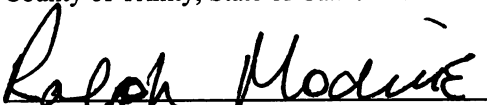
ADJOURNS TO CLOSED SESSION 12:08
