9:00 A.M. 1 CONSENT AGENDA

The Board examines the Consent Agenda Items presented for consideration and on motion of Supervisor Reiss, seconded by Supervisor Erikson and carried, Consent Agenda Items 1a. through 1 cc., excluding Items 1 a., 1 c., 1 d., 1 j., 1 k., 1 x. & 1 y., are approved with the following vote polled: 5-1-2-4-3-Ayes.

- 1 b. Approves and authorizes the County Administrative Officer to sign the agreement between County and Shasta Cascade Credit Bureau to provide credit report services for the CDBG Housing Rehabilitation Program. Subject to routing and approval as to form and content.

- 1 e. Pursuant to Trinity County Code Section 2.60.410 (2), authorizes hiring Amy Alward, as Deputy Probation Officer I, Range G166, Step B, effective July 3, 2000.
- 1 f. Authorizes Hospital Administrator, David L. Yarbrough, to enter into Agreement with Debra Martin, Certified Vascular Technologist, Fiscal Impact of \$50 per study, subject to routing and approval as to form and content.
- 1 g. Waives reading and directs the Clerk to let the record show that the Ordinance amending the Trinity County zoning ordinance by revising and merging the Floodplain Management Ordinance and Flood Hazard/Flood Hazard Overlay zoning districts, is enacted.
- 1 h. Approves and authorizes Linda Wright, Director of Health and Human Services Department, to sign the agreement with AIDS Drug Assistance Program, Office of AIDS, subject to routing and approval as to form and content.
- 1 i. Approves and authorizes Linda Wright, Director of Health and Human Services Department, to sign the Standard Agreement for Employment Services with EDD, subject to routing and approval as to form and content.
- 1 l. Approves Budget increase to Department of Transportation in the amount of \$150,000 due to the receipt of unanticipated revenue from the Office of Emergency Services for prior year claims.
- 1 m. Approves end of year budget transfer, from the Department of General Services, in the amount of \$21,743, to balance out budget.
- 1 n. Approves end of year budget transfer, from the Department of Solid Waste, in the amount of \$305,543, to balance out budget.
- 1 o. Approves and authorizes Chairman to sign 1 year contract between County and Tom's Trash for solid waste disposal, subject to routing and approval as to form and content.
- 1 p. Approves and authorizes Chairman to sign agreement authorizing Trinity County Probation Department to utilize County of Del Norte Bar-O-Ranch on a "space available" basis. Subject to routing and approval as to form and content.

- 1 q. Approves and authorizes Linda Wright, Director, Health and Human Services Department, to sign contract CW-2000-37 with University of California, Davis for Child Welfare Training, in the amount of \$11,600, subject to routing and approval as to form and content.

Fletcher, Ph.D, to provide consultation services for Tobacco Education. The maximum payment to the consultant under this agreement is \$3,500, subject to routing and approval as to form and content.
- 1 t. Approves and authorizes Chairman to sign the FY 2000/2001 Medi-Cal Cost Avoidance Program Certificate of Compliance, in the amount of \$443, subject to routing and approval as to form and content.
- 1 u. Approves and authorizes Chairman to sign Second Amendment to Lease Agreement with Trinity Occupational Training (TOT) for additional office space, in the amount of approximately \$73 per month, which is included in the budget for the Frontier Nutrition Project, subject to routing and approval as to form and content.
- 1 v. Approves and authorizes Chairman to sign Third Amendment to Lease Agreement with Trinity Occupational Training (TOT) for additional office space, in the amount of approximately \$510 per month, which is included in the budget for the Health and Human Services Department, subject to routing and approval as to form and content.
- 1 w. Approves and authorizes Chairman to sign the FY 2000/2001 County Subvention Certificate of Compliance from the California Department of Veterans' Affairs, in the amount of \$7,492, subject to routing and approval as to form and content.

- 1 cc. Pursuant to Trinity County Code Section 2.60.410 (2), authorizes hiring Johni Atterberry as Eligibility Worker II, Range G152, Step B. The requested advanced step results in an approximate \$820 annual increase in salary, effective July 5, 2000.

 - 1 d. On motion of Supervisor Erikson, seconded by Supervisor Reiss and carried, waives reading and lets the record show that the Ordinance amending the Trinity County Code Section 9.20 (Night time Curfew for Minors), is enacted.


