### 1. CONSENT AGENDA

- 1 a. Approves minutes of October 3, 2000, as submitted by Clerk.
- 1 d. Approves and authorizes Chairman and the Director of Behavioral Health Services to sign contract between County of Butte and Trinity County Behavioral Health Services, for psychiatric

- inpatient services for Trinity County Behavioral Health Services, in the amount of \$14,000, no impact to general fund. Subject to routing and approval as to form and content.
- 1 e. Approves and authorizes Chairman and the Director of Behavioral Health Services to sign contract between Marilyn Wooley and Trinity County Behavioral Health Services, to perform psychological testing and counseling for Trinity County Behavioral Health Services, in a maximum amount of \$2,000, no impact to general fund. Subject to routing and approval as to form and content.
- 1 f. Approves and authorizes Chairman and the Director of Behavioral Health Services to sign contract between Scott La Fein and Trinity County Behavioral Health Services, for counseling and case management of SED designated adolescents for Trinity County Behavioral Health Services, in a maximum amount of \$5,000, no impact to general fund. Subject to routing and approval as to form and content.
- 1 h. Approves application for waiver of fees in accordance with Trinity County Policy Statement No. 3-91 (P) from Ruth Lake Community Services District, for a \$750 fee being charged by the Planning Department.
- 1 i. Awards the construction contract to Shelter Roof Company, Redding, California in the amount of \$17,927.00, including contract provisions for additional work as may be necessary based on the condition of the joist and sheeting, for the Junction City Community Center Roof Rehabilitation, and authorizes the Chairman to sign the Notice of Award and other contract documents.
- 1 k. Approves and authorizes County Administrative Officer to sign Right of Way Contract State Highway, Temporary Construction Easement contract, in the amount of \$1,000, subject to routing and approval as to form and content.
- 1 b. On motion of Supervisor Reiss, seconded by Supervisor Stewart and carried, pursuant to code section 2.60.420(D), authorizes out of class assignment for Carol Bradford from RN II to Home Health Director with 5% increase in compensation from (G)208G \$22.2817/hour to \$23.3958/hour effective September 21, 2000 and waives 60 day waiting period.

On motion of Erikson, seconded by Supervisor Stewart and carried, approves and authorizes Chairman to sign the amendment to the Petroleum Contract agreement #00-1319, in an increase of \$1,440 for fiscal year 2000/01, with the California Department of Food and Agriculture. Subject to routing and approval as to form and content.
