2. CONSENT AGENDA

The Board examines the Consent Agenda Items presented for consideration and on motion of Supervisor Reiss, seconded by Supervisor Erikson and carried, Consent Agenda Items 2a. through 2r., excluding Items, 2i., 2j., 2q., are approved with the following vote polled: Supervisors Erikson, Reiss, Miller, Modine and Stewart.

All contracts submitted to the Board are subject to routing for approval as to form and content.

- 2a. Approves minutes of December 19, 2000, as submitted by Clerk.
- 2b. Reconsiders action taken by the Board of Supervisors on December 5, 2000 to increase the allocation of 2 Public Health Nurse Trainee, I or II, Health Department to 3 Public Health Nurse Trainee, I or II; to Allocate 1 Public Health Nurse I or II, Human Services, and direct that said change be made to the salary schedule and alphabetical listing of positions. Fiscal impact approximately \$25,079 in salary and benefits, effective December 1, 2000.
- 2c. Establishes the position of Child Support Ombudsman/Customer Service Coordinator at Range G162 in the Family Support Office effective January 1, 2001 and direct that said change be made to the salary schedule and alphabetical listing of positions; and

- accepts the Ombudsman/Customer Service Allocation of \$65,000 from the Department of Child Support Services which will increase the Family Support budget in the amount of \$53,411.
- 2d. Pursuant to Trinity County Code Section 2.60.410 (2), authorizes hiring Brian Burke as General Services Maintenance Worker Carpenter III, Range G170, Step C, effective December 1, 2000.
- 2e. Pursuant to Trinity County Code Section 2.60.410 (2), authorizes hiring Marian Staehr as Business Services Representative, Range G122, Step E, effective January 1, 2001.
- 2f. Pursuant to Trinity County Code Section 2.60.410 (2), authorizes hiring Tracey Berry as Business Services Representative, Range G122, Step E, effective January 1, 2001.
- 2g. Pursuant to Trinity County Code Section 2.60.410 (2), authorizes hiring Jason Mansfield as Environmental Services Worker I, Range G122, Step B, effective January 1, 2001.
- 2h. Changes allocation in the Department of Behavioral Health from 4.5 Mental Health Services Specialist I or II to 6.5 Mental Health Services Specialist I or II; and directs that said change be made to the salary schedule allocation list and list of alphabetical positions; fiscal impact is approximately \$28,575 (no impact to general fund), effective January 1, 2001.
- 2k. Approves destruction of employment applications, rating sheets and selection materials not currently under litigation, grievance or dispute, dated prior to December 31, 1998.
- 2I. Approves and authorizes Trinity Hospital Administrator to sign contract between Alliance Imaging, Inc. and Trinity County, upon recommendation of the Trinity Hospital Board of Directors, for Magnetic Resonance Imaging (MRI) services. Fiscal impact unknown, but anticipated revenue to exceed expenditure by \$15,000 for the remainder of the fiscal year.
- 2m. Finds no objection to the issuance of a one-day alcoholic beverage license for the Rotary Club's annual Chinese New Year Dinner at the Trinity County Veteran's Memorial Hall on January 27, 2001.
- 2n. Approves and authorizes Chairman and the director of Behavioral Health Services to sign contract between Empire Alcohol Recovery Center and Trinity County, in the amount of \$9,000, not to impact

- County general fund, for a residential care facility for drug and alcohol abuse clients to receive services.
- 20. Approves and authorizes the Chairman to sign the 2000/2001 Medi-Cal Administrative Activities and Targeted Case Management (MAA/TCM) Host Entity Agreement Between the County of Trinity and County of Solano. The participation fee for Trinity County is \$1,131, with no impact to county general fund.
- 2p. Accepts the work performed by Ken Reynolds of Fortuna, CA on Contract No. 00-FENCE-1, and authorizes the Director of Transportation to sign and record the Notice of Completion on said contract.
- 2r. Waives reading and directs the clerk to let the record show that an Ordinance amending Trinity County Code Chapter 3.28, Transient Occupancy Tax, is enacted.
- 2i. On motion of Supervisor Erikson, seconded by Supervisor Reiss and carried, establishes position of Network Administrator, in the Information and Technology Department at Range N227 effective January 1, 2001; and directs that said change be made to the salary schedule and alphabetical listing of positions; and
 - approves job specification for Network Administrator. Approximate increase in salary and benefits to the end of the fiscal year would be \$28,029. Increase in revenue would be \$45,000 annually.
