### 1. CONSENT AGENDA

1a. Approves minutes of March 6, 2001, as submitted by Clerk.

- 1b. Pursuant to Trinity County Code Section 2.60.410 (2), authorizes hiring Joe Bielawicz, as Deputy Marshal I, S103, Step C, effective March 1, 2001.
- 1c. Ratifies CAO's signature on the extension of the Option Agreement to Purchase for the Wetlands Reserve Program between the United States Department of Agriculture, Natural Resources Conservation Services (NRCS) and the County of Trinity originally executed August 28, 2000.
- 1e. Approves and authorizes Hospital Administrator to sign amendment with CMSI Group/CMSI The Travel Nurse Company/RNS Incorporated, in an amount not to exceed \$25,000, dated October 3, 2000, which is raising the hourly rates of licensed personnel.
- 1f. Approves and authorizes Hospital Administrator to sign amendment to Personal Service Contract with Alliance Imaging, Inc., dated January 30, 2001, no current fiscal impact at this time.
- 1g. Approves and authorizes Hospital Administrator to renew/sign Services Agreement, with North State Waste, in the amount of \$10,500 per year, effective immediately.
- 1h. Approves and authorizes Hospital Administrator to sign amendment to the contract dated April 1, 2001 with Jayson High, dba, Mountain High, for Cardio Pulmonary Services, in the amount of 10% increase in monthly reimbursement cost (\$1,573.00/month) and \$15.00 per call back increase in call backs exceeding 20 per month at an estimated increase of \$250/month, effective April 1, 2001.

- 1k. Approves and authorizes Chairman and Director of Behavioral Health Services to sign agreement with Skyway House in the amount of up to \$17,600 for an alcohol and drug residential recovery program for clients.
- 11. Appoints Edward "Ted" Klemm as the local mental health director.

- 1p. Approves and authorizes Chairman to sign resolution to authorize the Environmental Services Joint Powers Authority (ESJPA) to apply for a household hazardous waste grant on behalf of Trinity County.
- 1q. Authorizes County Clerk to conduct all elections throughout the calendar year 2001.

- 1s. Approves and authorizes the Chairman to sign the Glassy-Winged Sharpshooter amendment to Contract agreement #99-0821 with the California Department of Food and Agriculture. The amount of this agreement is decreased by \$4,633.29 for a total not to exceed \$10,824.82 for fiscal year 2000/01.
- 1d. On motion of Supervisor Modine, seconded by Supervisor Miller, waives reading and directs the Clerk to let the record show that an ordinance amending Trinity County Zoning Ordinance #315, reflecting the change in APN: 009-510-45 (Munro, P-2000-33) from Rural Residential to Highway Commercial, in enacted, with corrections.
