- 1b. Pursuant to Trinity County Code Section 2.60.410(2), authorizes hiring Diane Campion, as a Substance Abuse Specialist II at Range G170 Step C at Trinity County Behavioral Health, effective December 14, 2001.
- 1c. Pursuant to Trinity County Code Section 2.60.410(2), authorizes hiring Mia DeVault, as a Mental Health Services Specialist II Range G182 Step C, at Trinity County Behavioral Health, effective January 1, 2002.
- 1d. Changes allocation of 5 Solid Waste Worker I or II or III (1 seasonal 7 month position) to 11 Solid Waste Worker I or II or III (1 seasonal 7 month position) in the General Service Department and directs that said change be made to the Salary Schedule Allocation List and List of Alphabetical Positions, effective December 1, 2001.

- 7c. On motion of Supervisor Modine, seconded by Supervisor Stewart, finds that Gibson Heating and Air is the lowest qualified bidder; and approves and authorizes Chairman to sign agreement with Gibson Heating and Air, in the amount of \$33,673, for the replacement of the Sheriff HVAC System.
- 7d. On motion of Supervisor Reiss, seconded Miller and carried, approves and authorizes Chairman to sign Amendment Number 1 to contract with Yingling construction, to increase the maximum amount to \$18,760.75, for change orders in the amount of \$3,867.75, for work performed at the Wood Center/Business Incubator Building in Hayfork.
