7. PROPOSALS FOR TITLE III FUNDS "SECURE RURAL SCHOOLS AND COMMUNITY SELF-DETERMINATION ACT OF 2000".

The Secure Schools and Community Self-Determination Act of 2000 requires that, subject to determination of eligibility, proposals being considered by the Board of Supervisors be given a 45 day comment period prior to approval, pursuant to Title III of that act.

On motion of Supervisor Reiss, seconded by Supervisor Miller, considers, pursuant to Title III Secure Rural Schools and Community Self-Determination Act of 2000, the following proposals and directs that said proposals be published in the Trinity Journal on July 10, 2002. Supervisor Erikson – No:

- 7a. Proposal from the Trinity County Life Support, in the amount of \$3,800, for no labor operations of the Volunteer Paramedic Boat Patrol Program on Trinity Lake.
- 7b. Proposal from General Services, in the amount of \$355,000, to purchase equipment (tub grinder, articulating backhoe & bucket & front end loader, and roll off truck for transportation) to provide fuel reduction (fire fuels) for residents and landowners.
- 7c. Proposal from the Hyampom Community Services District and Hyampom Volunteer Fire Department, in the amount of \$40,970, for a 1200-1500 gallon Water Tender/Pumper and fire fighting gear.
- 7d. Proposal from the Hayfork Volunteer Fire Department, in the amount of \$19,960, to install four 5400 gallon water storage tanks, in four diverse parts of the greater Hayfork Valley to supply water to replenish fire engines during wildland and/or structure fires.

- 7e. Proposal from the Downriver Volunteer Fire Company, Inc., in the amount \$50,000, to fund the architectural fees to cover the preliminary design of a building site, leveling of the lot and securing a well for a fire station and Community Center downriver.
- 7f. Proposal from the Trinity County Amateur Radio Emergency Service, in the amount of \$350, for the replacement of radio system, antenna system and associated cables.
- 7g. Proposal from the Hayfork Action Team for Tourism and Recreation, in partnership with the Watershed Research and Training Center, in the amount of \$100,000 for trail rebuilding and maintenance within the Hayfork basin.
- 7h. Proposal from the Junction City Alpine Adventure Club, in the amount of \$19,093, for forest related educational activities and purchase of equipment.
