#### 7. PUBLIC HEARING

**OPEN PUBLIC HEARING:** On appeal of Planning Commission to approve a use permit to allow placement of a health care mobile home on property located on a private drive off of Carrville Loop Road, near the community of Coffee Creek. APN 007-730-16

#### **CLOSE PUBLIC HEARING**

On motion of Supervisor Reiss, seconded by Supervisor Miller, motion passes with a 3-2 vote to grant a use permit for a health care mobile home to Norma Johnson for Assessor's Parcel Number 007-730-16, based on the following findings and conditions:

#### Findings:

- 1. Both the County Health Officer and a licensed physician have provided written verification confirming that there is an existing medical need for temporary in-home care.
- 2. The intended occupant of the mobile home cannot reasonably be housed in the principal dwelling unit on the parcel.
- 3. The zoning of the subject property permits the location and installation of a mobile home.
- 4. The requirements of the Health Department, Building Department, and other public agencies have been met.

The use permit is approved subject to the following conditions:

- 1. The applicant shall comply with all regulations and permit requirements of the County Building Department.
- 2. The mobile home shall meet the 50-pound snow load requirement.
- 3. The permit shall terminate when the mobile home is no longer necessary for Norma Johnson's medical needs.
- 4. Running gear, including tires, shall remain operable and attached to the mobile home at all time.
- 5. Skirting may be affixed to the mobile home for energy conservations, but no skirting or other improvements, including, but not limited to, cabana, ramada, deck, or porch, shall be affixed or placed adjacent to the mobile home which may limit its immediate mobility. An access ramp and deck may be affixed to provide handicap access.
- 6. The applicant shall comply with the requirements of Public Resource Code section 4291 (fire safe ordinance).
- 7. The permit shall be valid for a period of two years from July 16, 2002, subject to renewal as set forth in section 30.B.9.c of the Trinity County Zoning Ordinance.

- 8. In the event that Norma Johnson no longer resides in the mobile home, or if the need for the health care mobile home ceases, the mobile home shall be removed from the property within 30 days.
- 9. This use permit shall be reevaluated in one year by the Trinity County Planning Department, in conjunction with the Division of Environmental Health to ensure that the requirements of the conditions of this permit continue to be met.
