PLEDGE OF ALLEGIANCE

1. CONSENT AGENDA

The Board examines the Consent Agenda Items presented for consideration and on motion of Supervisor Reiss, seconded by Supervisor Freeman and carried, Consent Agenda items 1b. through 1u., with the exception of 1a., 1g., and 1v., are approved with the following vote polled: Supervisors Freeman, Reiss, Modine and Miller – Aye.

All contracts submitted to the Board are subject to routing for approval as to form and content.

BOARD CONSENT MATTERS

- 1b. Approves and certifies the annual certification form of the membership of the Trinity County Local Childcare Planning Council.
- 1c. Waives reading and directs the Clerk to let the record show that an ordinance amending Section 9.28.030 of the County Code pertaining to Discharge of Firearms at Ruth Lake, is enacted (Ordinance No. 1270).

ARTS COUNCIL

1d. Approves and authorizes Chairman to sign resolution to approve the 2003/2004 Trinity County Arts Council Plan as submitted to the California Arts Council by the Trinity County Arts Council and designate the Trinity County Arts Council to execute the 2003/2004 State-Local Partnership Program Grant Contract with the California Arts Council. Grant amount is \$30,000 for operating expenses (Resolution No.2003-017).

AUDITOR/CONTROLLER

- 1e. Authorizes the purchase of two Canon IR 600 copy machines and a FAX machine from Ray Morgan Company for use in the hospital, in the amount of \$27,254.59.
- 1f. Approves and authorizes Chairman to sign a declaration of intent to contract for FY 02/03 Emergency Medical Service Appropriation, in the amount of \$9,308 in EMS revenue.

BEHAVIORAL HEALTH SERVICES

1h. Approves and authorizes Chairman to sign an Amendment No. 2 with Skyway House (Contract No. 2003-060), in the amount of \$32,400, for the treatment of Trinity County Alcohol and Drug Clients.

BUILDING AND DEVELOPMENT SERVICES

1i. Approves waiver of County Building and Development fees, in the amount of \$63, for new electric service fee to install lights for a Light Up A Life tree at the Highland Art Center, as requested by Dawn Hospice.

CHILD SUPPORT SERVICES

1j. Approves and authorizes Child Support Director to sign the Annual Automation Cooperation Agreement (AACA) Extension and Plan of Cooperation with the California Department of Child Support Services (Contract No. 2003-066).

GENERAL SERVICES

- Authorizes use of the bio-combustor for heating the Wood Center/Business Incubator Building in Hayfork. No cost to General Fund.
- 11. Approves and authorizes Chairman to sign an agreement with Trinity Heating and Air to install a HVAC System in the Veteran's Memorial Hall (Contract No. 2003-062), in the amount of \$13,627.

HEALTH AND HUMAN SERVICES

- Approves and authorizes Chairman to sign agreement with Southern Trinity Health Services (Contract No. 2003-061), in the amount of \$26,000, for providing medical services or programs in accordance with Welfare and Institutions Code 17609 and 17609.0.
- 1n. Approves and authorizes Chairman to sign the Trinity County Privacy Policy, as required by the Health Insurance Portability Accountability Act (HIPAA) (Policy No. 2003-02), which establishes procedures consistent with the Board's support of the fundamental right to privacy of all its citizens and intent to be compliant with applicable Federal and State health information privacy and security laws, regulations, and policies.

PERSONNEL

10. Removes Risk Management division from Administration and Personnel and approves consolidation of said division with Auditor/Controller and directs that said change be made to the Salary Schedule and County Position Descriptions, effective March 1, 2003. 1p. Waives nepotism policy and authorizes hiring Robert Rapinac Jr. as a Project Specialist at \$12 per hour in Solid Waste division of General Services, effective February 24, 2003. Cost for FY 02/03 is \$6,700.

PLANNING

1q. Authorizes Planning Director to advertise for one person with expertise in aviation to serve on the County's Airport Land Use Commission; and

Authorizes the Airport Advisory Committee to review the applications and make a recommendation to the Board regarding the appointment to the County's Airport Land Use Commission of one person with expertise in aviation.

- 1r. Approves a one-year extension for an approved tentative map. Location: Junction City. Applicant: James Munro. P-2000-33.
- Waives reading and directs the Clerk to let the record show that an Ordinance amending Trinity County Zoning Ordinance No. 315-722, changing yard setbacks in agricultural zones as provided in Section 13.K, Section 13.1.G, Section 14.K, Section 14.L, Section 14.M, and 14.N. Applicant: Trinity County Planning Department (PW-02-09), is enacted.
- 1t. Waives reading and directs the Clerk to let the record show that an Ordinance amending Trinity County Zoning Ordinance No. 315-721, reflects the amendment to Section 21 (General Commercial Zoning District) to allow Adult Day Support Centers and an amendment to Section 10 (Definitions) to add a definition for Adult Day Support Centers (PW-02-06) is enacted.
- Waives reading and directs the Clerk to let the record show that an Ordinance amending Trinity County Zoning Ordinance No. 315-720, reclassifying APN 11-210-84 from Unclassified-B3-5 (U-B3-5) to Rural Residential five-acre minimum (RR-5), and flood Hazard (FH) on all that portion located within the 100-year floodplain of the South Fork of the Trinity River and Kerlin Creek, located on Lower South Fork Road, Hyampom. Applicant: V. Garrett (P-02-33), is enacted.

On motion of Supervisor Reiss, seconded by Supervisor Freeman, approves and authorizes Chairman to sign resolution Designating Lorrac Craig, Sheriff, Brian Muir, County Auditor/Controller and David Laffranchini, Undersheriff as Authorized Agents to Execute the Citizens Corps and CERT Assistance Grant Documents, for potential revenue in the amount of \$5,841 (Resolution No. 2003-016). Approves with the following vote polled: Supervisors Freeman, Reiss, Modine and Miller – Aye.

On motion of Supervisor Freeman, seconded by Supervisor Reiss and carried, approves and authorizes Chairman to sign amendment No. 1 to the lease agreement with Dick Morris, in the amount of \$4,250, for the extension of the lease for Arts Council Gallery and office space at 206 Main Street (Contract No. 2003-063). Comments received from Jim Cudziol, Arts Council Director.
- 2f. On motion of Supervisor Freeman, seconded by Supervisor Reiss and carried, directs Supervisor Modine to draft response to January 17, 2003, letter from County of Humboldt regarding the Klamath River Litigation PCFFA v. US Bureau of Reclamation (Civ.No. C02-2006 SBA). Comments from Tom Stokely, Planning Department.
