#### 1. CONSENT AGENDA

#### GENERAL SERVICES

- 1g. Approves and authorizes Chairman to sign contract with Peak Systems Inc. (Contract No. 2003-127), in the maximum amount of \$15,856.50, to service, repair or replace 3Com NBX system components.
- 1h. Approves and authorizes Chairman to sign Memorandum of Understanding with the Weaverville/Douglas City Parks and Recreation District (Contract No. 2003-126), which defines respective authority and responsibilities on conducting activities at Lowden Park.

#### 7. FINAL ENVIRONMENTAL IMPACT REPORT FOR THE EAST CONNECTOR ROADWAY PROJECT

7a. The Board also considered the oral statements by Elizabeth Johnson at the hearing. After considering

the written demand alleging violation of the Brown Act, and all evidence submitted in support thereof, no action was taken by the Board, and the Chairman directed County Counsel to send a written response to Elizabeth Johnson pursuant to Government Code section 54960.1.

7b. The Board received and considered the request for reconsideration dated March 17, 2003, from Elizabeth Johnson on behalf of the Organization to Preserve Trinity County, the letter dated April 1, 2003, from Elizabeth Johnson, and the exhibits attached to said letter, the staff report, the oral statements by Elizabeth Johnson, and the response by staff.
