TRANSPORATION

On motion of Supervisor Reiss, seconded by Supervisor Klipp and carried, directs County Counsel to prepare a Resolution calling for a consolidated Election on the 1st Tuesday of November 2003, to increase the "Transient Occupancy Tax" to 10% for the advertising and promotional benefit of Trinity County and appoints Supervisor Howard Freeman and Supervisor David Klipp to be the Board of Supervisors representatives to head a steering committee designed to promote the tax increase. Comments received from Dero Forslund, County Clerk/Recorder and Linda Hymas, Treasurer/Tax Collector.
- 2c. On motion of Supervisor Klipp, seconded by Supervisor Modine and carried, approves the report of the committee assigned to analyze the

problem of open, expired building permits and accepts the following solutions:

- 1. By September 1, 2003, the Building Inspector will review the open, expired permits and close any that are over 10 years old, \$2,500 or less in value and represent minor alterations such as installation of a water heater.
- 2. After they review the assessor will analyze the remaining open, expired permits to update his office's records and the tax roll. The assessor will return all the permits to the Building Inspector by January 1, 2004.
- 3. The Building Inspector will notify property owners by letter to come to his office and complete the required paperwork. Property owners will be allowed a 90-day period from the date of the letter to either come in and close the permit or contact the Building Inspector to make other arrangements. During the 90-day period no permit reinstatement fees will be charged. However, owners will still be responsible for inspection fees and other charges. If an owner does not take any action during the 90-day period reinstatement fees will be charged.
- 4. The Assessor and the Building inspector will make quarterly reports to the Board of Supervisors on the status of the project.
