1e. Designates the Trinity County Agricultural Commissioner as the Pierce's Disease Coordinator for the Pierces Disease Control Program (Glassywinged Sharpshooter) in Trinity County. No Fiscal Impact.

AUDITOR/CONTROLLER

- 1g. Approves budget increase of \$3,500 to General Services Building and Grounds/Professional Services from Provisions of Contingencies for Lyons Tree Service to top and trim trees at Junction City Park due to storm damage on December 28/29, 2003.
- 1h. Approves budget increase for Probation 2460 (JDF), in the amount of \$741.27, due to unanticipated Revenue.

1i. Approves budget adjustment for Building and Development Services, Airport Division to increase Airport Development Maintenance budget by \$52,222 (State Funds \$47,260.82, County Airport Funds \$5,222.00) to reflect the actual project cost and revised budget.

BEHAVIORAL HEALTH SERVICES

- 1j. Approves and authorizes Chairman to sign Amendment No. 3 with California Specialty Hospital d.b.a. St. Helena Hospital (Contract No. 2004-149), in the maximum amount of \$13,000, to continue to provide inpatient services to Trinity County Behavioral Health Clients.

BUILDING AND DEVELOPMENT SERVICES/AIRPORT DIVISION
