# Behavioral Health Services

BH1. On motion of Supervisor Freeman, seconded by Supervisor Morris and carried, approves Amendment No. 05-224.3 with Nancy Callahan to assist in the implementation of the Mental Health Services Act (Proposition 63), to provide ideas and suggestions for appropriate ways of meeting California Department of Mental Health Requirements for Funding under the Mental Health Services Act, to provide consultation on the formation of a Leadership Team and its procedures and to write the Community Services and Support Plan at a maximum cost to County not to exceed \$20,000 and shall be paid for from the Mental Health Services Act; and

Authorizes the Clerk to sign Certified Minute Order prior to the minutes being approved.

Supervisor representing District 4 and Supervisor District 2, Superior Court Judge, Sheriff, Chief Probation Officer, General Services Director and County Administrative Officer.

# **County Counsel**

CO1. On motion of Supervisor Jaegel, seconded by Supervisor Freeman and carried, ratifies Chairman's signature on 34-year lease agreement with Trinity County Historical Society for the J.J. Jackson Museum complex.

# Health and Human Services

- HH1. On motion of Supervisor Jaegel seconded by Supervisor Freeman and carried, approves Amendment No. 05-422.1 with Donald Krouse, MD., to provide supervision of medical professionals providing jail health services. Maximum amount payable is \$15,000, of which \$6,000 is for the term 2/1/06 to 6/30/06.
- HH2. On motion of Supervisor Freeman, seconded by Supervisor Morris and carried, approves Amendment No. 04-388.1, with State of California, Department of Health Services, revenue in the maximum amount of \$300,000. This contract allows the County to claim matching funds for the allowable actual costs of providing administrative activities necessary for the administration of the Medi-Cal Program. Allowable costs include expenses of staff and operating expenses and equipment costs necessary to collect data, disseminate information and carry out staff activities.
- HH3. On motion of Supervisor Freeman, seconded by Supervisor Jaegel and carried, approves Amendment No. 05.421.1 to contract with Michael Novak, P.A., to provide medical services at the Trinity County Jail and the Trinity County Juvenile Detention Facility. Maximum amount payable is \$22,500, of which \$12,500 is

for the term 2/1/2006 to 6/30/2006. Funding from Health Realignment.

HH4. On motion of Supervisor Freeman, seconded by Supervisor Morris and carried, approves the recommendation of the Trinity Child Abuse Prevention Council to support activities identified in proposals from community agencies as follows:
