Behavioral Health Services

BH1. BH2. On motion of Supervisor Reiss, seconded by Supervisor Morris and carried, approves Contract No. 06-032 with Psynergy Programs, Inc. from March 1, 2006 through FY 2006-07 for psychiatric residential services for Trinity County clients, in the amount of \$40,000, to be paid from Medi-Cal and Behavioral Health's allocation of Realignment funds.

Approximate cost in salary and benefits per month at the A Step would be \$3,180; at the C Step \$3,457.
- CA4. Pulls the allocation of Administrative Services Officer from General Services to the Building and Development Department and authorizes the promotion of an Administrative Services Officer, effective March 1, 2006. Approximate cost in salary and benefits per month would be \$5,929.
