LOCAL EMERGENCY PROCLAMATION

WHEREAS, Ordinance No. 2.40.070 of the County of Trinity empowers the Director of Emergency Services to proclaim the existence of, or the threatened existence of a local emergency when said County is affected or likely to be affected by a public calamity, and;

WHEARAS, the Director of Emergency Services of the County of Trinity does hereby find; that conditions severing the northern communities' of Trinity County from all services in which creates risk to the safety of persons within said county, road failure on State Highway 3 MPM 40.6, which began on the 15th day of March, 2016.

NOW, THEREFORE, IT IS HEREBY PROCLAIMED that a local emergency now exists thought said County, and;

IT IS FURTHER PROCLAIMED AND ORDERED that during the existence of said local emergency powers, functions, and duties of the emergency organization of this County shall be those prescribed by state law, by ordinances, and resolutions of this County; and that this emergency proclamation shall expire in 21 days after issuance unless confirmed and ratified by the governing body of the County of Trinity.
