1. Item #4 - Report Out from Each Agency's Currently Funded Programs

- a. Sheriff: Programs are the same, patrol continues to assist probation, jail is continued to collect data w/inmates. Stats provided as needed. Association meeting CDCR advise that they will close 2 prisons, bringing burdens on counties. New jail to continue to staff, dispatch center is being delayed due to 911 lines were unstable. Delayed to end of August for all companies to be joined in all together. Beginning of September is new opening date! New correctional staff in backgrounds. New HR director has contacts to get medical portion of backgrounds to be done in Oregon. Radio update, added additional frequencies. New regional 3 frequencies, if we get deployed we will have access to other agencies frequencies for mutual aid.
- b. **HRN:** AB109, have one person they are helping and waiting to assist another. Set back with Emergency Shelter Trailer was broken into, a door was ruined making it unsecure, a lot of things were stolen. With that they were able to get funding for new tiny homes currently under construction. Sold the old trailer which was going to cost more to repair than it was worth. Hoping for those to be delivered in the next few months, they have one trailer available as well as the motel rooms.
- c. **Probation:** Provided a detailed report regarding PRCS Stats. 11 PRCS cases, 4 warrants, 3 pending release date. Ruby explaining the detailed report that was sent out. Asking for input on anything else that should be added, no input from others. Informing of Lance and Tim switch between the juvenile and adult units. Bradford being sent back for Army Reserves, Josh Hamilton covering most of his duties.
