1. CONSENT AGENDA

- 1a. Approves minutes of August 7 and 14, 2001, as submitted by Clerk.
- 1c. Approves and authorizes Chairman to designate Terry Lee, Chief Probation Officer, as County Financial Evaluation Officer to make financial evaluations of defendants and other persons liable for reimbursable costs under the law.
- 1d. Authorizes transfer of \$5,318.70 from the Emergency Medical Facility Trust to the Hospital Enterprise Fund for the

purpose of purchasing special equipment to move obese patients, submitted by the Auditor's office.

- 1f. Awards contract to Plew Plumbing and Electrical, Inc. of Weaverville, California, for the Wood Center/Business Incubator project, in the amount of \$18,600 from #99-EDBG-690 grant funds, and authorizes Chairman to sign the Notice of Award and other contract documents, submitted by the Grants Department.
- 1g. Approves and authorizes the Chairman to sign a resolution authorizing the District Attorney to submit to the Department of Justice an application to receive funding for the Spousal Abuser Prosecution Program in the amount of \$50,400 for the period 7/1/01 – 6/30/02; and further authorizing the District Attorney to sign the Grant Award Agreement, including any extensions or amendments thereof.
- 1h. Approves and authorizes Chairman to sign Resolution authorizing the District Attorney to submit to the Office of Criminal Justice Planning, an application to receive funding for the Statutory Rape Vertical Prosecution Program, in the amount of \$50,000 for the period 7/1/01 – 6/30/02; and further authorizing the District Attorney to sign the Grant Award Agreement, including any extensions and amendments thereof.
- 1i. Approves and authorizes Chairman to sign the Trinity Transit Drug Testing Policy, submitted by the Planning Department.
- 1j. Approves and authorizes Commissioner to sign the High-Risk Pest Exclusion Contract #01-0202 for fiscal year 2001/2002 with the California Department of Food and Agriculture.
- 1l. Authorizes the transfer of \$500,000 from the Road Construction Reserve, No. 104, to the Road Fund, No. 102 and authorizes a repayment transfer when the Department of Transportation receives the first installment payment of the annual Federal Forest Reserve Funds.
- 1m. Accepts and authorizes the Director of Transportation to sign the Notice of Completion for Contract No. 01-PAVE-1, Road Widening and Asphalt Concrete Overlay on Morgan Hill Road, County Road No. 319, in the amount of \$314,866.52.

- 1n. Tables Ordinance amending Trinity County Zoning Ordinance No. 315, changing APN 010-260-23 from Agricultural Forest – forty acre minimum (AF-40) to Timberland Production Zone (TPZ) located on Black Bear Road, Weaverville, Applicant: Lancaster (P-01-03), to the September 18, 2001 meeting.
- 1o. Waives reading and direct the Clerk to let the record show that an ordinance amending chapter 1.08 of the Trinity County Code, Modifying Supervisorial Districts and Voting District Boundaries, is enacted with the following findings:
 1. The boundaries of the districts, as adopted, are consistent with the geographics and topography of the communities.
 2. The boundaries, as adopted, are consistent with the community development and parcel divisions with the County.
 3. The boundaries, as adopted, are consistent with postal delivery and school district boundaries.
- 1p. Finds no objection to the issuance of a one-day alcoholic beverage license to St. Patrick's Catholic Church, for the sale of beer for a fundraising Fiesta/Bazaar on Saturday, September 29, 2001 from 11:00 am to 4:00 pm, at Lowden Park. All proceeds will be directed to assist in the St. Patrick's building program.
- 1q. Finds no objection to an application for a one-day beer and wine alcoholic beverage license, as requested by the New York Saloon, for a beer booth to sell beer during the Livestock BBQ to be held on Saturday, September 8, 2001 between the hours of 11:00 am and 5:00 pm at the Lowden Park Cook Shack.
- 1r. Finds no objection to an application of a person-to-person alcoholic beverage license transfer, requested by the Victorian Restaurant – Victorian Mini-Mart, located at 1701 Main St. Weaverville.
- 1s. Approves and authorizes Chairman to sign authorization to proceed, as requested by Trinity County General Services Solid Waste Division, with Lawrence and Associates, in an

estimated amount of \$40,550 from the Solid Waste budget, for the following services:

1. Evaluate the drainage along the east side of the landfill.
 2. Develop a topographic map of the airport/landfill property.
 3. Develop closure plan for Hayfork Septage Ponds.
 4. Install gas monitoring wells.
 5. Perform groundwater monitoring and reporting.
- 1b. On motion of Supervisor Erikson, seconded by Supervisor Reiss and carried, waives Trinity County Code Section 2.60.420 (D) and approves out-of-class assignment of Sharon Saul, Deputy Director for Administration Quality Improvement, to Acting Director of Behavioral Health Services during Director's absence for less than 60 days effective June 26, 2001, in the amount of an approximate salary increase of \$353.00 for a sixty day period. On motion of Supervisor Miller, seconded by Supervisor Modine and carried, awards contract 01-BRIDGE-199 to Clemens Construction, Inc. of Redding, CA., for the Van Duzen River Bridge Replacement, in the amount of \$819,918.00, and authorizes the Chairman to sign contract documents and certificates, as submitted by the Transportation Department.

On motion of Supervisor Modine, seconded by Supervisor Miller and carried, designates Steven W. Judson, Chief Building Inspector/Engineer, as the Director of the Trinity County Building and Development Services Department.

- 6b. On motion of Supervisor Miller, seconded by Supervisor Erikson and carried, designates Trinity County Environmental Health Division as the Local Solid Waste Enforcement Agency (LEA) and authorizes Environmental Health Division to apply to the California Integrated Waste Management Board for LEA status. The implementation of the solid waste program will result in an approximate savings of \$6,600 annually.

- 6c. On motion of Supervisor Erikson, seconded by Supervisor Miller and carried, authorizes the Application for State Aeronautics Grant Funds, Certify the Availability of Matching Funds, authorizes the Director to sign the Grant agreements for Weaverville Airport, in the amount of \$74,000 State and \$8,222 County; Hyampom Airport, in the amount of \$59,000 State and \$6,555 County; and Ruth Airport, in the amount of \$80,000 State and \$8,888 County; and authorizes the inclusion of the Projects into the Final FY 2001-02 Trinity County Budget and authorizes Budget Transfer of Matching Funds from Special Aviation Development Fund 0154 to Airport Development Maintenance Fund 0153. Funding all projects requires \$23,665 County Match from the Airports Development Account.
