AGRICULTURE/SEALER/SOLID WASTE

- 1.01 Approves Franchise Permit contract no. 07-057, for the sole purpose of collection, transportation and disposal of commercial waste from USFS/BLM camps to the Weaverville Transfer Station for emergency disasters such as fires, floods, etc. The permit will begin on April 3, 2007 and expire on April 3, 2008, subject to routing and approval as to form and content.

Fiscal Impact: None

- 1.02 Approves the Waste Tire Products contract no. 07-064, beginning on April 3, 2007 and expiring April 3, 2010 to provide waste handling, recycling, and disposal services for our CRT's/E-Waste.

Fiscal Impact: Revenue \$45,000

- 1.03 Approves Agreement # CCC.07003 contract no. 07-059, with the California Department of Corrections and Rehabilitation for Solid Waste to provide garbage pickup and disposal.
