BEHAVIORAL HEALTH SERVICES

Approves 7 year Lease Agreement No. 07-154 with Enrico and Mary Kay Raffanti for building commonly known as Raffanti Building No. 1, to house the County's Behavioral Health Services Department. Subject to routing and approval as to form and content.

Funds in Current Budget: \$233,000 for the first year.

BUILDING AND DEVELOPMENT
