Project Title: Digital 299 Broadband Project (Lake or Streambed Alteration Agreement No. 1600-2021-0083-R1)

Project Location (include county): Various locations for approximately 300 miles generally following State Route 299 in Humboldt, Shasta, and Trinity Counties.

Project Description: The California Department of Fish and Wildlife (CDFW) has executed Lake and Streambed Alteration Agreement number 1600-2021-0083-R1, pursuant to section 1602 of the Fish and Game Code to the project Applicant, Vero Fiber Networks, as represented by Operations Director Karen Collins.

The Project includes installing approximately 300 miles of fiber optic cable along existing roads which includes 525 water crossings and up to six prefabricated buildings to support signal regeneration, distribution, and interconnection (In-line amplifier buildings). The Project will occur in two phases: first phase includes construction of the middle-mile fiber optic facilities and vaults, which will be buried, and the second phase consists of connecting the last-mile connections to existing utility poles. Three construction methods are proposed to account for variations in geology and terrain or environmental sensitivities: horizontal directional drilling (HDD), plowing, and trenching with either a trencher, backhoe, or rock saw.
