The Board examines the Consent Agenda Items presented for consideration and on motion of Supervisor Erikson, seconded by Supervisor Reiss and carried, Consent Agenda Items 1a through 1u, excluding Items 1a, 1p, 1q and 1e, are approved with the following vote polled: 5,1,3-Ayes

1 b. Approves job specifications for Accountant I, Accountant II and Accountant III, at Ranges G179, G189 and G199 effective April 1, 2000 and changes allocation in the Department of Transportation from one Accountant to one Accountant I, II or III, and changes allocation in the Auditor's Office from one Accountant to one Accountant I, II or III, and directs that said change be made to the salary schedule.

1 c. Accepts recommendation of Hospital Administrator and makes the following allocation changes:

- Increases the allocation for Purchasing Assistant I/II from 2 full time to

3 full time.

- Deletes the full time allocation for Central Supply Coordinator.

- 1 d. Authorizes a Secret Witness Fund to be administered by the Sheriff, and directs that all account information be subject to review by the Auditor.
- 1 f. Authorizes Director of Transportation to solicit proposals from qualified firms to perform Botanical Surveys in accordance with Federal and State requirements and enters into a Personal Services Contract with the firm or firms submitting the Lowest Responsible Proposal(s) on four separate bridge projects and the Hyampom Road reconstruction project between Post Mile 6.5 and 8.3. Furthermore, authorizes the Director of Transportation to sign said personal services contracts subject to routing as to content and form.
- 1 g. Approves supplement No. 1 to Trinity County standard form personal services contract for Van Duzen Bridge, 5C-199 between the County of Trinity and Quincy Engineering in the amount of \$9,266.00, subject to routing and approval as to form and content.
- 1 h. Approves a salary increase for Barbara Webb, Children Services Supervisor II from Range M217B to M217C effective February 1, 2000.
- 1 i. Authorizes the Chairman and the Sheriff to sign the State of California Department of Boating and Waterways Financial Aid Agreement for FY 2001-2002.

- 1 o. Authorizes Chairman to sign letter endorsing and congratulating the California Fish and Game for their efforts on the proposed rules for salmon in the Klamath-Trinity system as recommended by the Trinity County Fish and Game Commission.
- 1 r. Approves the resolution adopting the deferred compensation CalPERS plan.
- 1 s. Changes allocation of 4 Account Clerk I or II, or Accounting Technician I (maximum of 3 Accounting Technician I) to 4 Account Clerk I or II, or Accounting Technician I or II (maximum of 3 Accounting Technician I and 1 Accounting Technician II) within the Treasurer/Tax Collector Department and directs that said change be made to the Salary Schedule Allocation List and List of Alphabetical Positions, effective April 1, 2000.


