1. CONSENT AGENDA

The Board examines the Consent Agenda Items presented for consideration and on motion of Supervisor Reiss, seconded by Supervisor Stewart, Consent Agenda items 1a. through 1y., excluding items 1b., and 1l., are approved with the following vote polled: Supervisors Stewart, Reiss, Modine, Miller and Erikson-Aye.

All contracts submitted to the Board are subject to routing for approval as to form and content.

- 1a. Approves minutes of March 5, 2002, as submitted by Clerk.
- 1c. Pursuant to Trinity County Code Section 2.50.410 (2), authorizes hiring Phyllis Nicolls as Director of Food Services for the Jail Kitchen at Range M176E, effective April 1, 2002. Cost for FY 01/02 is \$471.

- 1d. Pursuant to Trinity County Code Section 2.60.410 (2), authorizes hiring Alan Schrader as a Mental Health Clinician II, Range G199, Step C, at Trinity County Behavioral Health Services, effective April 8, 2002. Cost for FY 01/02 is \$675.
- 1e. Pursuant to Trinity County Code Section 2.60.410 (2), authorizes hiring Susan Fritz as Library Assistant/Shasta College Outreach, Range G132, Step B at the Hayfork Branch Library, effective March 5, 2002. Cost for FY 01/02 is \$254.
- 1f. Approves 2.5% out-of-class compensation for Vicki Thompson, effective February 2, 2002 for a period not to exceed 90 days and approve 2.5% out-of-class compensation for Donna Loving, effective February 2, 2002 for a period not to exceed 90 days. In the absence of the Administrative Services Officer, it has been necessary to divide the duties. The Health and Human Services Director is requesting to compensate Vicki Thomson and Donna Loving for performing the duties of the Administrative Services Officer. Cost for three months would be \$1,696 per person.
- 1g. Decreases allocation for Welfare Fraud Investigators from 2 to 1 and increase allocation for District Attorney Investigators from 2.4 to 3.4, effective April 1, 2002.
- 1h. Authorizes General Services Department to sell 2 additional vehicles at the surplus vehicle sale. A 1985 Jeep CJ7 and a 1985 Dodge Ram Pickup. The number and amount of bids received predicate the revenues.
- 1i. Approves and authorizes Chairman to transfer from Probation Department, a 1972 Ford 4x4 pick-up to the Trinity County Sheriff's Posse.
- 1j. Authorizes Sheriff to sign FY 2002, Financial and Operating Plan for Cooperative Patrol USFS, Shasta-Trinity and Six Rivers National Forests. Potential revenue up to \$31,200.
- 1k. Approves and authorizes Chairman to sign contract amendment with the California Department of Alcohol and Drug Programs. This is the final amendment of the County's Negotiated Net Amount contract with the Department of Alcohol and Drug Programs. The total contract amount of \$761,213 has not changed.
- 1m. Approves and authorizes Chairman to sign the 02/03 Agreement #02-25142 with California Department of Health Services; and

Approves and authorizes Chairman to sign the Certification of Non-Federal Matching funds for Medi-Cal Administrative Activities. This will allow the County to claim up to \$120,000 in matching funds.

- 1n. Accepts Canvass of March 5, 2002 Primary Election completed on March 12, 2002 and directs the Clerk to let the record show that the Official Statement of Votes Cast is hereby made a part of the minutes of the Board of Supervisors, and declares the following elected to the offices specified effective January 7, 2003:

- 1o. Waives reading and directs the Clerk to let the record show that an Ordinance amending Trinity County Zoning Ordinance #315, rezoning the north half of APN 25-590-60 from Retail Commercial (C-1) to Multiple Family (R-3), located at the corner of First and Fremont Streets, Lewiston, is enacted. (Applicant: D. Ryan, P-01-59).
- 1p. Finds that there is no advantage to the County to request competitive bid for asphalt concrete and premix, and authorizes the Chairman to sign Addendum #2 to the Agreements with Thomas R. Bess of Carlotta. Fiscal impact of \$88,500.
- 1q. Finds that there is no advantage to the County to request competitive bid for asphalt concrete and premix, and authorize the Chairman to sign Addendum #2 to the Agreements with Eagle Rock, Inc. of Weaverville. Fiscal impact of \$225,000.
- 1r. Approves the Amendment to Standard Form Personal Services Contract for Environmental Studies and Permits for the Widening and Realignment of approximately 2 miles of Hyampom Road (Post

Miles 6.4 to 8.4) and Hayfork Nine Mile Bridge, with Hughes Environmental Consultants of Sacramento, California, and authorizes the Director of Transportation to sign Contract Amendment. Fiscal impact of \$15,000.

- 1s. Approves the Standard Form Personal Services Contract with Natural Resources Management Corp. of Eureka, CA for On-call biological resource surveys, to be performed on an as-needed basis over a 3-year period, under individual task orders. Authorizes the Director of Transportation to sign the Master Personal Services Agreement subject to routing and approval as to content and form, and authorizes the Director of Transportation to enter into supplemental agreements for specific tasks under this master agreement the total of which shall not exceed \$100,000 over the 3-year period.
- 1t. Approves the Standard Form Personal Services Contract with North State Resources, Inc. of Redding, CA for On-call biological resource surveys, to be performed on an as-needed basis over a 3-year period, under individual task orders. Authorizes the Director of Transportation to sign the Master Personal Services Agreement subject to routing and approval as to content and form, and authorizes the Director of Transportation to enter into supplemental agreements for specific tasks under this master agreement the total of which shall not exceed \$100,000 over the 3-year period.
- 1u. Approves the Standard Form Personal Services Contract with Remote Possibilities of Weaverville, CA for On-call biological resource surveys, to be performed on an as-needed basis over a 3-year period, under individual task orders. Authorizes the Director of Transportation to sign the Master Personal Services Agreement subject to routing and approval as to content and form, and authorizes the Director of Transportation to enter into supplemental agreements for specific tasks under this master agreement the total of which shall not exceed \$40,000 over the 3-year period.
- 1v. Approves the Memorandum of Agreement with Trinity County Resource Conservation District of Weaverville, CA for on-call biological resource surveys, to be performed on an as-needed basis over a 3-year period, under individual task orders. Authorizes the Director of Transportation to sign the Master Agreement subject to routing and approval as to content and form, and authorizes the Director of Transportation to enter into supplemental agreements for specific tasks under this master agreement the total of which shall not exceed \$30,000 over the 3-year period.

1b. **PULLED:** 1 full time allocation at the Hospital, for Division Director/Ancillary Services at range N233, effective immediately. This position will be eligible for standby/on-call compensation, with call-backs at two hour minimum. Effect for FY 01/02 is a savings of approximately \$3000.

1l. On motion of Supervisor Modine, seconded by Supervisor Stewart and carried, approves and authorizes Chairman to sign Amendment 1 to Department of Health and Human Service's Master Agreement Contract 01-15110, for a maximum payment by the State of \$189,750, this will decrease the amount the State will pay the County by \$63,250; and

Approves and authorizes Chairman to sign Amendment 1 to the corresponding Memorandum of Understanding for AIDS education and prevention activities, E&P 01-53. This amendment will decrease the amount the State will pay the County by \$54,000. Comments received from Linda Wright, Health and Human Services Director.
