- 1i. On motion of Supervisor Freeman, seconded by Supervisor Modine and carried, approves and authorizes Chairman to sign Amendment No. 1, to the contract with Gordon H. Chong and Partners (Contract No. 2003-496), increasing the maximum amount from \$10,000 to \$20,000, for architectural services at Trinity Hospital. - 1k.
