If an incumbent (the person who currently holds office) does not file Declaration of Candidacy papers on or before August 12, 2022; the deadline for any eligible candidate other than the incumbent is extended until 4 p.m. on August 17, 2022.

NOTICE IS FURTHER GIVEN An appointment to each elective office will be made as prescribed by Section 10515 in the event there are no nominees or an insufficient number of nominees for the office and a petition for an election is not filed with the elections official within the time period prescribed by Section 10515.
