Finding #1: Mail service

Response: Agree

Recommendation #1: Implemented

New officers working in the jail will receive training in rules regarding the inspection of inmate mail with emphasis on confidential mail.

Finding #2: Medication complaints Response: Agree with reservation

Recommendation #2: To be implemented over time

Inmates are generally informed by medical staff about the use of generic medications. Including a statement to that effect will be added to the next printing of the inmate handbook. The responsibility of the quantity of meds on band is the responsibility of the medical staff. Every effort is made to insure that an inmate does not run out of meds.

Finding #3: Inmate phone system Response: No response requested

Finding #4: Inmate housing cleanliness Response: No response requested

Finding#5: Facility repairs

Response: Agree

Recommendation #5: Implemented

General Services has been notified about necessary repairs to the jail facility. Those requests have been listed as capital assets and they are awaiting finding. Reminders are sent on a regular basis.

Conclusion: School trained staff continues to be a problem as Deputies are working in the jail and they receive minimal training in their academy. Their training is acquired as a function of on-the-job training. Inmate care is still a primary consideration of this Department. Finding #1: Mail Service

Response: The Trinity County Board of Supervisors agrees with the finding.

Recommendation #1: Will been implemented. Action has been taken by the Sheriff to include this topic in the training program for new officers working in the Jail. The training will include rules and regulations pertaining to confidentiality requirements regarding inspection of inmate mail.

Finding #2: Medication Complaints

Response: The Trinity County Board of Supervisors agrees with the finding.

Recommendation #2: Will be implemented. All inmates should be informed of current policy with regard to generic medication. The Sheriff has agreed to include this in the next printing of the inmate handbook. Finding #3 & #4: Inmate Phone System

Finding #5: Facility Repairs

Response: The Trinity County Board of Supervisors agrees.

Recommendation #5: Has been implemented. The Trinity County Board of Supervisors is aware of the deficiencies and those deficiencies have been reported to the General Services Department. The shower repair is listed as a priority for funding and every effort will be made to find funding for this project this fiscal year.
