JUVENILE DETENTION FACILITY

PURPOSE:

California Penal code section 919(b) mandates that the Grand Jury will annually inquire into the conditions and management of all public prisons within the county. In Trinity County that includes three facilities: Trinity River Conservation Camp, Trinity County Juvenile Detention Center and Trinity County Detention Facility.

BACKGROUND:

The Juvenile Detention Facility in Weaverville was completed in June, 2001. It is operated under the direction of the Chief Probation Officer, Mr. Terry Lee and members of his staff. The main purpose is to provide a location for juveniles to be held pending court appearances, to keep them in a safe environment or a place of incarceration as ordered by the court.

There is a capacity to house up to 24 detainees. It houses individuals from Trinity County and depending upon availability of beds, can provide housing for juveniles from other counties. In those cases, fees are paid to provide services to this county. The fees are placed in the General Fund for distribution to the Probation Department and other General Fund departments.

METHOD OF INVESTIGATION:

The Judicial Committee met with Mr. Lee at the Juvenile facility for an interview and a tour of the facility. Following a brief talk about the facility, its history and general operation the jury members where taken on a full tour of the building. They were permitted to view all areas with the exception of a counseling room, where a counseling session was being held. He explained procedures used by law-enforcement when interviewing juveniles when in classes at Trinity High School as well as other times.

The facility was found to be exceptionally clean and organized, and should be noted that the inmates are responsible for the cleaning of the facility. The kitchen was clean and everything in its proper place.

Male and female juveniles are housed on separate tiers. There are showers on each floor and set up to provide maximum privacy. Classes are provided for all inmates. Classes were in session and the jury was invited in to observe. The instructor explained that the students are provided an excellent education, offering classes over and above those required by the State of California. Defined as "Life Classes" some of those

include writing checks and balancing a check book, making a menu, creating a shopping list, and using those to shop. They learn to fill out an application for renting an apartment, getting utilities set up for the apartment, and how to look for and buy an automobile. In general, they are instructed on how to get along on their own. In speaking with the students they said how glad they are to have such classes, as most of them "had no clue."

All the detainees were well mannered, neatly dressed and polite. They seemed to be in good spirits. They have a system where they can earn rewards with good behavior and privileges could be lost for rule infractions.

FINDING #1:

Several questions were received by this jury regarding the procedures used by law enforcement when speaking with a student at Trinity High School. There appears to be confusion over the proper procedures, on the part of the students, the parents, and the general public.

RECOMMENDATION #1:

It is recommended that a member of the Probation Department speak annually at the Student Orientation sessions held at public, continuation and alternative schools so that the students understand their rights relating to the Probation Department. It should be explained how the department can approach the students and under what conditions. It should also be explained what are illegal and inappropriate behaviors. Much of this could be accomplished in the form of a brochure outlining this information to be included in the parent packet provided at the beginning of the school year.

CONCLUSION:

In light of the Budget restraints, Chief Probation Officer Terry Lee and his staff are to be commended on the care and compassion they give to the young people in their care. The clean, well managed facility they maintain is one the entire county can be proud of.
