- 5. Grant Updates Philip Simi
  - a. Emergency Management Performance Grant (EMPG)

Recent modification to EMPG21 – additional funding for CodeRed and CrisisTrack to support OES and county departments in getting messaging out to the community and to support disaster management and damage assessments.

- b. Homeland Security Grant Program (HSGP)
  - HSGP22 Received award letter. Projects include CodeRed, SCHMRT, Emergency Alert Sirens, equipment upgrades for the TCSO Mobile Command Trailer, IT infrastructure.
- c. Public Safety Power Shutoff (PSPS)- An extension was granted until the end of 2023
  Generator and transfer switch for the courthouse are in. Working on final details as to how the generator will be placed (permanent vs. temporary).

Awarded \$30k grant from HAF to purchase fire shelters for TCSO. Some shelters have arrived, waiting on the remainder.

Karl: Working with OES on the Public Health Frontier grant to place Ham Radio's in 21 locations throughout the county, and add a new repeater to Pickett Peak and Ironside mountain to enhance communications during a disaster or communication loss situation.

- e) California Tribal TANF Partnership: Jana Reese
- f) Cal OES: Robert Goyeneche and Rick Ehlert Robert- Siskiyou is dealing with the aftermath from the multiple fires that occurred this year. Also let CalOES know early when asking for assistance and include any background. Rick- Hazard Mitigation funding summit coming up in Sacramento. CalFire is releasing Fuels Reduction grants. Dealing with fire recovery for Mariposa, Placer, and Siskiyou Counties.
- g) CAO: Letty Garza: Nice to see the in person participation for this council. The Board of Supervisors will hold a special session on Thursday 11/10/22 at 3:00 pm to address the Canyon Creek slide.
- h) CHP (California Highway Patrol): Brandon Lale Weather is changing along the 299 corridor, chain restrictions are R1, R2 and R3. Brandon is trying to upload video of the conditions on the CHP face-book page for real time information. Cal-trans on-time app is another great resource for these conditions.
- i) District Attorney Victim-Witness: Jessica Tillinghast and Joni Wiley We have "Stop the Bleed" kits for first responders.
- j) DOT: David Colbeck- Canyon Creek slide is still active. This has been an ongoing slide since it began in December of 2021. There is a hard closure in place for that area. There are 27 parcels located behind the slide, there are provisions for emergency vehicles to pass if needed. No ETA on the road opening.

- n) HHS Public Health Branch: Marcie Jo Cudziol The state emergency declaration for the covid pandemic is projected to end at the end of February. Marcie Jo (PHB Director) supplied information on Health Officer powers around threats to the public health including those from communicable diseases (see information Marcie Jo emailed out to the council). This is important to understand as covid continues to pose a threat (endemic) although not at the scale we have seen during the pandemic, but also with threats of other communicable disease outbreaks. The process of imposing restrictions through Health Officer orders should always include discussion with County Council and CDPH. CDPH also has authority laid out in regulation and it is important to note that Health Officers can be more restrictive within their jurisdictions but not less restrictive than CDPH Directives. PODs for Flu and COVID will be held in Weaverville and Hayfork. Marcie Jo will be providing vaccination for children under 3.

  - q) OES: Philip Simi I commend the TCSO for their handling of the active shooter incident yesterday. The early coordination with outside agencies including Redding SWAT team, CHP and others, although tragic, without their professionalism and knowledge, this situation could have been much worse.

- w) Schools: Sarah Supahan and Fabio Robles –Sarah, TCOE did not receive the Code Red alert for the active shooter incident on Monday, 11/7/22, nor did the Rise academy that is right in the path of the incident. Sarah requested that TCSO dispatch contact TCOE for any incident requiring school lock-down, and they will contact each school and advise of the situation. Under Sheriff Ward agreed that one call would also take the load from the dispatchers. Fabio- Trinity Alps School district appeared to be the only school contacted for the lock-down. Fabio would like to meet with TCSO regarding the Point of Contact for when a lock-down is needed.
- x) Sheriff: Bryan Ward Evacuation Zones We are in the process of developing descriptions for each zone. We will put together a group to review the zones, develop written descriptions, then proofread for accuracy. CodeRed alert originators will be able to load the SHP file, add the zone descriptions and the alert message. The evacuation zone map shows evacuation status of all of the evacuation zones. Similar to Butte County, we would like for TC Search and Rescue (SAR) to take over the responsibility of sending out the Code Red and remove that work from the TCSO dispatchers. The dispatch center has completely moved into the new jail. The 911 system was down for about 4 hours due to a cut line, (not TCSO lines) during this time, calls were sent to other centers, some out of state. TCSO is working on getting a redundant system in place. Bryan gave a time-line of the active shooter incident that took place on Monday 11/4/22, agencies from as far away as Anderson responded. He also stated that this is still an active investigation.

CAO Letty Garza asked why there were no road blocks: CHP Brandon Lale stated that no one knew which direction he would go. When you block the road, you could put incident people at risk in an uncontrollable environment.
