



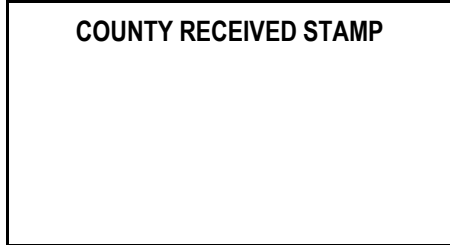

Specialty Cottage Outdoor	\$750.00 License Fee/365 days =	\$2.05/day
Specialty Cottage Mixed Light	\$1,500.00 License Fee/365 days =	\$4.11/day
Specialty Cottage Indoor	\$2,000.00 License Fee/365 days =	\$4.48/day
Specialty Outdoor	\$3,000.00 License Fee/365 days =	\$8.22/day
Specialty Mixed Light	\$3,000.00 License Fee/365 days =	\$8.22/day
