Re: Update to Trinity County Commercial Cannabis Cultivation Licensing Process

Reprinting Licenses to Reflect Valid Period for One Year from Date of Issuance

We are reprinting all Trinity County Commercial Cultivation Licenses to reflect an updated expiration date. Although licenses issued in 2018 were all set to expire by March 31, 2018, the Trinity County Board of Supervisors approved a revised approach in which your license will be good for one year from date of issuance. The anniversary date for each license is determined by the last date that the license was issued. For new applicants, the anniversary date will be established by the date that the license is first issued.

Meeting State and County Deadlines

We are in the process of confirming deadlines associated with each of our applicants and licensees. We first identified all applicants and licensees whose State Temporary License or whose county license on or before March 31, 2019, and are processing each one to facilitate ongoing State or County licensing status so that each site remains in good standing as a legal, valid operation.

Public Notification Process

To facilitate each licensee's ongoing compliance with State and County licensing schemes, we are processing renewals by the order in which their deadlines occur. Currently, licensees are bound by deadlines established by a State Temporary license or County license. County staff is responding to both deadlines and prioritizing notifications for each site to meet all applicable deadlines. The public notification process facilitates your compliance with CEQA or your ability to confirm that compliance with CEQA is "underway."
