Item #3 – Review of Budget Requests

Received two budget requests, status quo, DA office to continue AB109 population & SO request for the Correction Officer and Sheriff's Deputy, have not received from HRN. Trisha Alberg stating that she didn't know she needed to send a request, needs to send Budget Request to Robi.

Item #4 – Overview of Current Budget

Robi does not have all numbers needed to provide accurate numbers for the upcoming year. Probation Office will be requesting status quo with assumptions based on current salaries, staffing, and step increases coming. Robi was only able to base on the benefit levels from last year, as we have not received the current budget packet as of yet. The budget provided in the packet was based on the previous year. This year ask for approval of the budget with the credo that it is amended based on the new levels when the numbers are provided.

Motion to adopt the 2022/2023 proposed budget with increases based on the benefit costs for the 2022/2023 that will be in the County Budget package.

Item #5 - Report Out from Chief Probation Officer of updated Annual CCP plan update

CPO Ruby Fierro: updated Annual CCP plan Was due Dec 15.

The Budget act of 2020 requires counties submit an updated Community Corrections Partnership Plan and annual report.

- Essentially shared that I am a new Chief to the County and coming through COVID and major fires no new goal have been determined in a strategic plan. Goals remain.
- Indicated new DRC services with SO Work release when new jail is operational.
 Re-entry focus w/ assessment and Multi-disciplinary services. Improve transitional housing.
- Funding priorities are Basic supervision and case management. Expand EBP and new innovative programming.

Item #6 - Report Out from Each Agency's Currently Funded Programs

a. Sheriff:

Deputy position continuing to assist Probation needs and warrant services, Correctional deputy continuing to collect data on any new bookings in jail, covid affected our justice involved person's numbers in facility, CDCR froze intake due to covid, recently continued again. Issues having to transport to Kern County, due to CDCR closing reception center in Tracy. Making officers out for 2 day transport.

Butte County offered temporary pathway point, working on alternatives. Jail got contract approval with Frontier, was a big delay for 911 systems. Remaining parts for the H-Vac system came in, for heating and air for cells. Training portion starting soon, operational goal is end of May beginning of June. Training venues have offered to come in.

b. HRN:

Housing AB109 emergency shelter travel trailers, in local parks. Have secured CDBG Cares Act funding for "Tiny Homes" Upgraded travel trailers. Things being stolen, will be better pluming. Bid coming from Forever Tiny Homes out of Cottonwood. Will be getting 3 Tiny Homes.

c. Probation:

- Stats are going back to 2011. In the future, the data will be presented somewhat differently. It tells more of a story
- o Since the passage and implementation of AB109, Trinity County has received a total of 144 Post Release Community Supervision (PRCS) CDCR packets. There are currently 13 PRCS offenders under supervision, with 5 in active warrant status at this time. 2 inmates are currently pending release from CDCR.
- o 71 offenders have been sentenced under 1170(h) PC since the program began, for a total of 1657 months (138.08 years), and an average of 23.33 months per offender. 23 of these were split sentences under Mandatory Supervision (MS), and 6 Mandatory Supervision cases are currently active.
- The supervision period for the 23 MS cases after jail was served was a total of 539.5 months (41.5 years) for an average of 23.5 months supervision per offender.
- Annual comparison.
