University of Cincinnati is contracted to review the recording of our staff interacting with the population and scoring and provide feedback to increase successful and consistent skill in this model for the Probation Officers.
 - ii. Tim Saxon asks for clarification of what we are paying for. Clarified for UCI staff to evaluate and provide feedback to staff. Fidelity.
