Trinity County Coronavirus (COVID-19) Health Advisory

TRINITY COUNTY – COVID-19 Vaccination \$50.00 Visa/Master Card Incentive ends at 11:30 PM on April 2, 2022.

In the fight against COVID-19, vaccinations have proven to be an important tool to ensure protection against severe illness, hospitalization, and death. On August 7, 2021, Trinity County Public Health Branch (TCPHB) secured a grant to provide \$50.00 Visa Cards or Master Cards for all vaccine doses of Trinity County residents obtained on or after that date.

With long travel distances between vaccination resources and many communities in our county, TCPHB in collaboration with the Public Health Institute, obtained this grant to offset added costs of accessing vaccine as well as to incentivize all residents of Trinity County to obtain vaccination and protect our businesses, health care systems, schools, each other, and our communities at large.

COVID-19 Vaccination is an important front line defense in the continued fight to protect Trinity County residents, communities, businesses, health care systems, and schools. The \$50.00 Visa/Master Cards will continue to be available for any Trinity County resident vaccinated with any dose of COVID-19 until 11:30 PM on April 2, 2022. Anyone vaccinated after 11:30 PM on April 2, 2022 will no longer receive the \$50.00 Visa/Master Card.

As a reminder, only persons vaccinated after August 7, 2021 (start date of the incentive program) are eligible for the \$50.00 Visa/Master Card for any dose obtained on or after that date and up to the end date of the program on April, 2 2022.
