Trinity County – As of today, there are no confirmed cases of COVID-19 in Trinity County. Trinity County Health and Human Services (HHS) Public Health Branch (PHB), and the Office of Emergency Services (OES) continue to work together in coordinated response to the COVID-19 pandemic.

Local and statewide orders put in place by the Trinity County Health Officer and the Governor’s Office of California remain in effect. As a reminder, it continues to be critical that we hold off the spread of COVID-19 in Trinity County through the effective Non-Pharmaceutical Interventions (NPIs) currently in place:

- Staying home unless seeking essential services
- Maintaining distance between you and those around you
- Not gathering with individuals outside of your home
- Frequently cleaning surfaces
- Washing your hands frequently with soap and warm water
- Face coverings may be effective in preventing the spread of COVID-19 by asymptomatic individuals
