### ***Governor's Budget Funds Last Year's \$300M Baseline Commitment to Public Health***

SACRAMENTO, CA — California Can't Wait, a coalition of public health officials, local leaders, frontline workers, and health equity advocates applauded the Governor's January budget proposal for including \$300 million in added, ongoing state funds to begin rebuilding the state's battered local public health infrastructure and increase our public health workforce. Coalition members urge the Governor and Legislature to invest additional funding to address recruitment, retention, and pipeline challenges to ensure California's public health workforce is prepared for the next crisis and deliver on the state's health equity goals, coalition members said today.

**Michelle Gibbons, Executive Director, County Health Executives Association of California:** "COVID-19 taught an unforgettable lesson: waiting until a crisis to invest in public health costs lives. California's local health departments are encouraged that Governor Newsom's budget keeps the commitment made last year to begin rebuilding our deeply under-resourced and understaffed local public health departments. Reversing a decade of steep decline in funding for life-saving public health functions is a critical first step toward preparing for the next crisis before it's too late.

"Two years into a pandemic that is still breaking devastating records, it's more clear than ever California's public health workforce must be prepared to defeat public health threats still in our midst - the spread of STDs, tuberculosis and an epidemic of chronic diseases - as well as risks on our horizon like climate change. Local public health agencies in every community are California's frontline in the fight to protect the health of all Californians and achieve health equity, and to do so, we must focus on strengthening the public health workforce pipeline."
